

The GDPR Clause

of Mulcan Consulting informs that in relation to the obligations arising from Regulation 2016/679 of the European Parliament and of the Council of the EU of April 27th 2016 on the protection of individuals regarding personal data processing and the free movement of such data, as well as the repeal of Directive 95/46 / WE (the so-called GDPR), the personal data provided by you will be processed by **Jarosław Mulcan LIGERO**", owner of **Mulcan Consulting**, with the registered office address: Szymanów, Lipowa 32, 51-180 Wrocław, NIP: 9531102643 e-mail address: office@mulcanconsulting.eu, who will become the Administrator of this data.

1. Obtaining information on the processing of personal data is possible by contacting **Jarosław Mulcan LIGERO**, the owner of **Mulcan Consulting** at the contact address listed above.

2. **Jarosław Mulcan LIGERO**, the owner of **Mulcan Consulting** will process your personal data for the purposes indicated below, on the basis of specific premises and for the depicted time period:

- 1) presenting the Administrator's commercial offer - processing is based on your consent (the legal basis is art. section 1 letter a) of the GDPR). Your personal data will be processed until the consent is withdrawn or an objection is raised,
- 2) establishing, investigating and defending against any claims - processing is necessary for the purposes of the Administrator's justified interests. In this case, the legal basis is Art. 6 sec. 1 lit. f) GDPR). Your personal data will be processed until the point of expiry of potential claims,
- 3) in order to analyze customer satisfaction - processing is necessary for the purposes of the justified interests of the Administrator (Article 6 (1) (f) of the GDPR). Your personal data will be processed for a period of 1 year,

- 4) marketing related to the Administrator's personal services - processing is necessary for purposes resulting from the justified interests of the Administrator (Article 6 (1) (f) of the GDPR); personal data will be processed until an objection is raised,
 - 5) marketing concerning the services of the Administrator's partners - processing takes place on the basis of your consent (Article 6 (1) (a) of the GDPR); personal data will be processed until the consent is withdrawn or an objection is raised.
3. Your personal data will be made available to:
- 1) state authorities - on the basis of legal provisions,
 - 2) the Administrator's partners in order to present a commercial offer - based on your expressed consent,
 - 3) delivery companies, postal operators.
4. You have the right to access your data, to correct it, to delete it, or limit its processing, as well as to object to data processing, including the marketing of the personal services of **Jarosław Mulcan LIGERO**, the owner of **Mulcan Consulting** and to transfer data. You are entitled to withdraw your consent to the processing of data at any time, as well as to present a complaint in relation to the processing of data to the supervisory body - the President of the Office for Personal Data Protection. 5. Providing personal data for the purpose of:
- 1) presenting a commercial offer, measuring your satisfaction and marketing the services of the Administrator and his partners are voluntary, therefore the failure to provide data for these purposes will result in the inability to fulfill the objectives for which they are collected,
 - 2) providing data in relation to the presentation of a commercial offer, conducting marketing activities, and conducting a satisfaction survey is voluntary.
